CASE #13-013

Interim Superintendent Genelle Yost informed the Board that Case #13-013 was an expulsion hearing pertaining to a 15 year old female student (JG/DOB-03/07/1998) from Fort Pierce Central High School who was charged with a violation of the Code of Student Conduct, Rule B3-Battery of a Student, that occurred on the school bus. The student was given a due process hearing before a hearing officer on June 3, 2013. A written summary of this hearing was provided for the Board and the student's parent (s). The recommendation for expulsion was reviewed by the Placement Review Committee on which the Exceptional Student Education Department is represented. The Committee recommended that expulsion proceedings continue. The student and her mother were present during the hearing and were given the opportunity to make a statement.

CASE #13-011

Neither the student nor a representative appeared before the Board with regard to the scheduled expulsion hearing for a 19 year old male student (TM/DOB 07-28-1993) from Fort Pierce Westwood High School. Final disposition was postponed until the next School Board meeting (August 27, 2013). No action was taken by the Board on this matter.
