Minutes:

Chairman Kathryn Hensley called the July 19, 2011 Special (Expulsion) Meeting to order in the School Board Room at approximately 5:38 p.m. Members present were Chairman Kathryn Hensley (residing in District No. 4), Member Debbie Hawley (residing in District No. 1), and Member Donna Mills (residing in District No. 3). Members absent were Vice Chairman Carol A. Hilson (residing in District No. 2) and Member Troy Ingersoll (residing in District No. 5). Superintendent Michael J. Lannon and School Board Attorney Daniel B. Harrell also attended the meeting.

RECOMMENDED ORDER #11-020 - Superintendent Lannon informed the Board that Case No. 11-020 pertained to a 16 year old student (DOB-01/27/1994) from Delaware Avenue School who was charged with a violation of the Code of Student Conduct, Level Rule I 3 - Misuse of Telecommunication Services. The student was given a due process hearing before a hearing officer on March 24, 2011. A written summary of this hearing was provided for the Board and the student's parents. The recommendation for expulsion was reviewed by the Placement Review Committee on which the Exceptional Student Education Department is represented. The Committee recommended that expulsion proceedings continue. The principal and hearing officer recommended the Board expel the student for the remainder of the 2010-11 school year and the first semester of the 2011-12 school year. The student and his mother were present during the hearing and were given the opportunity to make a statement.

The Superintendent recommended the Board expel the student from the regular program of instruction of the St. Lucie County School System for the remainder of the 2010-11 school year and the first semester of the 2011-12 school year, provided, however, that during the first semester of the 2011-12 school year, the Student shall be eligible for re-enrollment, on a probationary basis, in an after-school credit recovery program, at such school site, and under such conditions as the Superintendent determines appropriate. In the event of any violation of the student and re-schedule and re-notice the instant expulsion proceedings, and the alleged violation of probation conditions, for final action by the School Board (Mills/Hawley/Carried 3-0).

RECOMMENDED ORDER #11-028 - this matter was postponed; no action was taken by the Board.

Motions:

The Superintendent recommended the Board expel the student for the remainder of the 2010-11 school year and the first semester of the 2011-12 school year, provided that during the 2011-12 school year, the student shall be - PASS eligible for re-enrollment on a probationary basis, under a contract, in an after-school credit recovery program as determined appropriate by the Superintendent.
