5. Resolution on High-Stakes Testing (Revised)

Minutes:

St. Lucie West K-8 teacher, Diane Hanfmann, read the Resolution on High Stakes Testing wherein the Board resolved to call upon Florida's governor, state legislature and state education boards and administrators to re-examine public school accountability systems in this state and to develop a system based on multiple forms of assessment which does not require extensive standardized testing, more accurately reflects the broad range of student learning, and is used to support students and

improve schools, and to call upon the U. S. Congress and Administration to overhaul the Elementary and Secondary Education Act, currently known as the "No Child Left Behind Act," reduce the testing mandates, promote multiple forms of evidence of student learning and school quality in accountability, and not mandate any fixed role for the use of student test scores in evaluating educators.

Mrs. Hensley stated board members had been discouraged from considering this Resolution--it was politically unpopular, but this Board takes a stand for things that are right and board members will try to get other districts to follow likewise.

Following Mrs. Hensley's comments, Superintendent Lannon presented a video intended to accurately inform parents and other community members about the potential impact of the legislated changes to students and teachers. It also pointed out that the district's work was more than the FCAT, and that St. Lucie County Public Schools are in the business of people development and watching students' backs as they journey on a path to their dreams.

36. Teacher Evaluation System Update (Revised)

Minutes: Superintendent Lannon reported that the Teacher Evaluation System was imposed through Senate Bill 736 by Florida Legislature. Staff has been working on the evaluation system through the collaborative bargaining process since it became law and before that in anticipation that it would become law. In keeping with the Student Success Act, the Teacher Evaluation System is based on student performance and teacher observations. District staff, in collaboration with CTA, has been diligently working to meet the student performance requirement as outlined in Florida Statute. The state will calculate the teacher impact on student growth based on FCAT results and other testing. In classes where there is no FCAT, the District negotiated the use of subject area final exams or safe exams as a means of determining student performance. These exams will be used as the students' final exam in applicable courses. The exams were developed based on test questions submitted from teachers of the tested courses. The test questions were compiled into a single exam for the course that will be provided district-wide. Final exams will be administered to students later this month. The regular exam schedule can be found on the District website as part of the assessment calendar. Mr. Lannon stated the District continued to refine its application of the law and this will be done together as has been done in the past. All parties agree this is not a perfect system but we are bound to follow it as constitutional officers and teachers of the state of Florida.
