#### Minutes:

Recommended Order #10-008 pertained to a 17 year old (JH/DOB/07-26-1992) student at Dale Cassens Educational Complex who was charged with Code of Student Conduct violation G4-Disruption on Campus-Major. Following a June 4, 2010 due process hearing and upon review by the Placement Review Committee, the Superintendent recommended, and the Board took action to expel the student for the remainder of the 2009-10 school year and the entire 1010-11 school year (Hilson/Hensley/Carried 4-0, Carvelli absent).

Recommended Order #10-009 pertained to an 18 year old (BS/DOB/02-18-1992) student at St. Lucie West Centennial High School who was charged with Code of Student Conduct violations C4-Assault/Intimidation/Threat of Employee or Other Adult, and B3 - Battery of Student. Following a May 17, 2010 due process hearing and upon review by the Placement Review Committee, the Superintendent recommended, and the Board took action to expel the student for the remainder of the 2009-10 school year and the entire 2010-11 school year (Miller/Hilson/Carried 4-0, Carvelli absent).

Recommended Order #10-011 pertaining to student RB(DOB/08-09-1996) was withdrawn from the agenda.
