SPECIAL ORDERS OF BUSINESS

4. [Houghton Mifflin Harcourt Partnership Presentation and Update](#)

Minutes:

Mr. Allen Burgtorf, Vice President with Houghton Mifflin Harcourt, presented Jim McKenzie, Executive Director of the St. Lucie County Education Foundation, with a check for \$10,000 on behalf of the HMH partnership. Mr. McKenzie, on behalf of Foundation board members who were present, expressed gratitude for the contribution and noted that the funds would go towards scholarships for students. Mr. Burgtorf explained that HMH felt strongly about its commitment and presence in the community and this was just a start--his corporation expected to provide excellence for students, the community, and the organizations that make up the community. As a partner, and in recognizing it's social responsibility, Mr. Burgtorf stated HMH was committed to in excess of \$100,000 for these types of grant opportunities and scholarship funds.

Superintendent Lannon and Associate Superintendent Owen Roberts both updated the Board regarding the HMH partnership. HMH had started the hiring process regarding the Parent Academy and the early childhood aspect of the partnership. Staff was currently looking at a facility to house the Parent Academy, the employees of which would be hired by HMH but who would work in St. Lucie County. The curriculum for adult learning parenting skills was in place and conversation to build a data warehouse had been started. Dr. Robert Marzano's framework for teacher effectiveness had been adopted and staff was moving forward with the adoption of a science fusion product that would allow delivery of science curriculum through virtual as well as labs.

The HMH partnership would total \$105,000 over a five year period: \$37,500 to fund the continuation of the Young Floridians Program; \$37,500 to help fund the district's "Night of the Starts" recognition program; \$7,500 for Teacher of the Year recognition, and \$30,000 (over a four year period) would go towards \$5,000

scholarships including the current \$10,000 contribution.

5. [St. Lucie County Education Foundation Technology Grant Awards & Teacher of the Year Award \(Revised\)](#)

Minutes: Mr. Jim McKenzie, Executive Director of the St. Lucie County Education Foundation, assisted by Mr. Glenn Rustay, asked the Board to recognize the following three teachers who were awarded a new laptop as Technology Grant winners, along with 2012 District Teacher of the Year Cristina Veresan: Kerryanne Monahan (Fort Pierce Central High), Tom McLaughlin (Southport Middle), and Marc Turrell (Oak Hammock K-8).

6. [Discovery Education Celebration of "Millionth View" \(Revised\)](#)

Minutes:

Discovery Education, represented by its Education Director Amy Knower, celebrated the St. Lucie County School District's millionth viewing of its electronic curriculum--at the school with the highest usage and in the school with the teacher of highest utilization of their programming. Discovery Education also hosted a small reception for students, teachers, and administrators prior to the meeting. During the Board meeting, Ms. Knower awarded Superintendent Lannon and Chairman Hensley with the Millionth View District Award. Karen Murphy, a teacher at St. Lucie Elementary, received the Millionth View Teacher Award. Ms. Knower commented that St. Lucie County had some of the most dedicated and passionate teachers that she had encountered in the world.

Minutes:

Garden City Early Learning Academy held a Kids at Hope Spring Fling on Saturday, April 9, 2011. It was a successful event with over 900 event visitors. Principal Teri Barenborg recognized the following sponsors for their support of this event: Calvary Chapel Port St. Lucie; Total Roofing; The SLC Education oFundation; Fastrac Electric; Harvest Food & Outreach; Walmart Distribution Center; Repgraphic Solutions and Seacoast Bank. Fort Pierce Police Chief Sean Baldwin described how "treasure hunters" and committee members had banded together to change kids (and families) into kids (and families) of hope. St. Lucie County is the first in the nation to have a countywide program.

Superintendent Lannon provided a power point presentation on the redevelopment of the district's current teacher evaluation system. Under Race to the Top, the district agreed to realign the teacher evaluation system. With the passing of Senate Bill 736, there is now a state requirement to revise the teacher evaluation system so that it aligns with the components outlined in the Bill. The Bill will become Florida Statute 1012.34 and will define the required elements for teacher evaluation in the state.

The system must be based on contemporary research of effective teaching practices that are strongly linked to student achievement. The district had selected the research of Dr. Robert Marzano on which to base the new evaluation system. Dr. Marzano's Framework is a causal model; if instructional personnel effectively use the teaching strategies in this framework, there will be a positive impact on student performance. In addition, the system must align with the newly adopted Florida Educator Accomplished Practices.
