

2025-2026 ESOL COMPLIANCE GUIDE

The following information is provided to answer questions about ESOL compliance for educators.

IDENTIFY YOUR CATEGORY AND DEADLINE FOR COMPLETION

Determine your category based on the subject(s) you teach:

| Category 4 | Administrator or Guidance Counselor | 60 in-service points OR 1 ESOL course | Hires prior to September 5, 2003: 3 years to complete from September 5, 2003 | Hires after September 5, 2003: 3 years to complete from date hired as school administrator or guidance counselor. |

CATEGORY 1: ELA/READING/DLA TEACHERS

This applies to teachers responsible for Language Arts, English, Developmental Language Arts, Intensive Reading, or Reading.

You must choose one of the following options:

| When you obtain the ESOL Endorsement, you also bank 300 points that you may use for future certificate renewals in any area. | Once you get the ESOL K-12 Certification, you keep it on your Florida educator's certificate if you've completed 120 ESOL in-service points or two (2) ESOL college classes before recertification. This must be done within three (3) years of adding the subject to your teaching certificate. |

Important:

When a Category 1 teacher who is not certified or endorsed in ESOL is assigned to teach an active ELL student, they are considered out of field (OOF). The teacher must work toward ESOL endorsement/certification, regardless of whether they have ESOL students in subsequent years. Starting in 2011-2012, Category 1 teachers must complete all ESOL training requirements within six years, including 60 in-service hours in the first two years and 60 hours each year afterward. Teachers can take more hours but cannot skip years or double up, aiming for continuous training to become proficient quickly and support ELL students.

Category 1 teachers MUST add the ESOL Endorsement or ESOL Certification to their teaching certificate to be in compliance.

CATEGORY 2: MATH, SCIENCE, SOCIAL STUDIES, COMPUTER LITERACY

This applies to a **secondary education teacher** who teaches Social Studies, Mathematics, Science, or Computer Literacy.

- Complete 60 ESOL in-service points OR 1 ESOL Endorsement course

Category 2 teachers CANNOT add the 60 ESOL in-service points to their certificate; an in-service transcript will document compliance.

CATEGORY 3: ELECTIVES (ART, MUSIC, PE, ETC.)

This applies to **elective teachers** not in Categories 1, 2, or 4 (e.g., Art, Music, Physical Education, Media Specialists, Speech-Language Pathologists, Occupational Therapists, Foreign Language teachers, etc.).

- Complete 18 ESOL in-service points OR 1 ESOL Endorsement course

Category 3 teachers CANNOT add the 18 ESOL in-service points to their certificate; an in-service transcript will document compliance.

CATEGORY 4: ADMINISTRATORS / GUIDANCE COUNSELORS

This applies only to **administrators and guidance counselors**.

- Complete 60 ESOL in-service points OR 1 ESOL Endorsement course

Category 4 teachers CANNOT add the 60 ESOL in-service points to their certificate; an in-service transcript will document compliance.

TRANSCRIPT & CERTIFICATION HELP

Any ESOL in-service or coursework completed outside St. Lucie Public Schools **MUST** be added to the teacher's in-service transcript on Frontline.

NOTES

- For ESOL Endorsement only - 3 semester hours or 60 in-service credits are required within two years of starting LEP student Language Arts instruction. Then, each subsequent year, the teacher must earn the same, until a total of 15 semester hours or 300 in-service credit points have been earned.
- All district-level administrators must train in the Consent Decree, Cross-Cultural communications, and delivering understandable instruction, but no specific in-service points or hours are mandated.
- As per K12 Memo 2006-121 and the Florida Course Code Directory, teachers teaching Developmental Language Arts or Reading to ELLs must obtain the ESOL Endorsement. Additionally, teachers teaching Developmental Language Arts instead of Intensive Reading need the Reading Endorsement by the beginning of the 2007-08 school year.
