Recommended Action	The Superintendent recommends the Board award ITB 25-11 to all responsive and responsible vendors as listed below and authorize Purchasing Department to renew the contract for three (3) additional one-year periods contingent upon annual contract performance review, with the initial term contract to commence on 4/14/2025 through 4/13/2026; Option Year 1 - 4/14/2026 through 4/13/2027, Option Year 2 - 4/14/2027 through 4/13/2028 and Option Year 3 - 4/14/2028 through 4/13/2029, as presented and attached to the agenda.

Description: The purpose and intent of the Invitation to Bid is to secure prices and establish a Term Contract with multiple vendors for Field Trip Charter Bus Service in and out of county. Vendors who are approved through the bidding process will be included in a list of approved vendors sent to all schools/departments. Schools/department will be directed to utilize only companies that are listed on the approved vendor list for transportation services. Because of the variables among field trips that affect cost, schools will be responsible for contacting the awarded bid vendors to determine which vendor can provide the service at the best rate.

117 vendors were solicited. Twelve (12) responses were received. The tabulation is attached for review.
