Recommended Action	The Superintendent recommends the Board award RFQ #25-08 to the responsive and responsible vendors that includes Proctor Construction Company, LLC, Paul Jacquin & Sons, Inc, The Morganti Group, Inc., and Remnant Construction, LLC, and authorize Purchasing Department to renew the contract for two (2) additional one-year periods contingent upon annual contract performance review, initial term contract to commence 2/12/2025 through 2/11/2026, Option Year 1 - 2/12/2026 through 2/11/2027 and Option Year 2 - 2/12/2027 through 2/11/2028, as presented and attached to the agenda.

This Request for Qualifications (RFQ) is to provide professional construction management support services for projects up to \$7,500,000 to the district. The selection of the services is pursuant to the Consultants Competitive Negotiation Act (CCNA), Section 287.055, Florida Statutes.

13,545 vendors were solicited. Ten (10) responses were received, one was deemed non-responsive.

The Evaluation Committee selected the four firms listed below for recommendation of award:

1. Proctor Construction Company, LLC
2. Paul Jacquin & Sons, Inc
3. The Morganti Group, Inc.
4. Remnant Construction, LLC

Initial term contract shall commence on February 12, 2025 through February 11, 2026.

Option Year 1 - February 12, 2026 through February 11, 2027
