performance review, the initial term contract to commence on 05/16/2025 through 05/15/2026; Option Year 1 - 05/16/2026 through 05/15/2027, Option Year 2 - 05/16/2027 through 05/15/2028 and Option Year 3 - 05/16/2028 through

05/15/2029, as presented and attached to the agenda.

Description: The purpose and intent of the Invitation to Bid is to establish a fixed discount off catalog price from a variety of vendor's catalogs for instructional supplies and equipment.

2290 vendors were solicited. Forty-four (44) responses were received. The tabulation is attached for review. Recommendation of award is for the 41 vendors that meet the minimum requirements of the bid.
