Type	Action (Consent)
Recommended Action	The Superintendent recommends the Board award RFP 23-01 to the vendors, as listed below, authorize Purchasing Department to renew the contract for three (3) additional one-year periods contingent upon annual contract performance review, the initial term contract to commence on 9/14/2022 through 9/13/2023; Option Year 1 - 9/14/2023 through 9/13/2024; Option Year 2 - 9/14/2024 through 9/13/2025; Option Year 3 - 9/14/2025 through 9/13/2026.

Description: This RFP is to implement a supplemental phonics curriculum for kindergarten through 12th grade at 37 schools. Additional schools may be added, if a need is determined. Ninety vendors were notified. Eighteen (18) responses were received. The scoring sheets are attached for review.

The Evaluation Committee selected the following firms for recommendation of award:

2. Benchmark Education Company, LLC
3. HEC Software
4. Really Great Reading Company, LLC
