The Superintendent recommends the Board award ITB 25-24 to the eight responsive and responsible vendors as listed below for an indeterminate amount and to authorize Purchasing Department to renew the contract for three (3) additional one-

authorize Purchasing Department to renew the contract for three (3) additional one-year periods contingent upon annual contract performance review. Initial term contract to commence 6/11/2025 through 6/10/2026, Option Year 1 - 6/11/2026 through 6/10/2027, Option Year 2 6/11/2027 through 6/10/2028 and Option Year 3

6/11/2028 through 6/10/2029, as presented and attached to the agenda.

Description: The invitation to bid (ITB) is to provide plumbing services on an as needed basis. This bid will be awarded to eight (8) contractors, one primary and seven (7) alternates. The primary contractor will be requested to perform the work required for projects with an estimated cost of \$3,000.00 or less. Each project estimated to be over \$3,000.00 will be given to all awarded contractors to quote as specified. The quote most advantageous to the Board, at its sole discretion, will be selected. The primary contractor will be Meeks Plumbing. The alternates are listed below (#2-8).

Eight vendors were notified. Nine (9) responses were received, 1 was non-responsive. The tabulation is attached for review.

Request authority for the Purchasing Department to renew the contract for three (3) additional one-year periods. Contract renewal shall be contingent upon annual contract performance review.
