The Superintendent recommends the Board award RFP 25-20 to the top twenty-six responsive and responsible vendors as described below and authorize Purchasing Department to renew the contract for three (3) additional one-year periods contingent upon annual contract performance review, initial term contract to commence 7/9/2025 through 7/8/2026, Option Year 1 - 7/9/2026 through 7/8/2027, Option Year 2 - 7/9/2027 through 7/8/2028, Option Year 3 - 7/9/2028

through 7/8/2029, as presented and attached to the agenda.

Description: This Request for Proposal (RFP) is to provide speech-language therapy and audiology services at various locations throughout the district for students who show communication disorders in the areas of language, articulation, fluency and voice. Due to that shortage and the need to provide services to our students with disabilities, the district must contract with outside agencies. The district currently has approximately 9 vacant positions, not including medical leave or other long-term leaves.

One hundred eighty-four (184) vendors were solicited. Forty (40) responses were received, 6 were deemed non-responsive. The scoring is attached for review.

The proposal evaluation committee determined that the District would be best served by awarding to the top twenty-six vendors. With a large number of vacancies, medical leave and other position needs (i.e. short notice), the Department may select firms from the list as needed to adequately provide services to children.
