The due date extension also applies to Attachment I, all references submitted through 1/6/2022, 3 PM will be accepted for RFP 22-013E.

Q1. Would you please explain how we should submit the pricing of the proposed equipment? Attachment J says to utilize this form to submit overall costs. Aren't you interested to see the unit costs of our proposed equipment? Is your decision solely based on a discount off list?

A1. You must complete Attachment J and provide an attachment showing your list price for all erate eligible equipment. See section 2.7 of the RFP for a full description of how we plan to evaluate cost.

Q2. Are we supposed to provide equipment pricing for all your existing equipment inventory as a complete replacement, or only price each replacement equipment model individually?

A2. You should provide list pricing of all your equipment that is erate eligible. You may also provide a replacement cost matrix for our existing equipment if so desired but that is not a requirement for your response.

Q3. Section 4 asks for pricing on equipment parts provided to repair installed equipment. Cisco partners do not repair the equipment. Instead, Cisco provides the warranty and replaces the faulty equipment. Is the information you are requesting the discount off Cisco's SmartNet contracts.?

A3. If you are unable to provide parts replacement for your equipment, please explain so in your response. The maintenance discount is for replacement parts and/or manufacturer provided coverage as stated in Attachment J.

Q4. Section 4 asks the vendor to provide current list pricing with the bid. How should the vendor submit this price? Can the vendor attach a quote with all individual models and unit prices? Will this attachment be evaluated?

A4. Yes.
